Terms, Conditions & Declarations



ADMISSION

- This scholarship offer is conditional upon the applicant submitting a masters study application to the School and satisfying all of the conditions stipulated in his/her offer of admission.

- Applicants must meet the School's minimum **English Language Requirements** at the time of application.

- Applicants must hold a first degree at either a first or upper second class level or at a lower second class level plus a masters degree at the time of application.

- By submitting an application for funding:

- the applicant is confirming that the information provided on their admissions and scholarships applications, and all supporting documents, is true and accurate.

- the applicant consents to his/her admissions and funding application documents, including uploaded supporting documents and references, being released to the scholarship subpanel.

- the applicant is agreeing to undertake a medical examination if selected by the Commonwealth Scholarship Commission (CSC).

-the applicant is confirming that they are permanently and continually resident in one of the following eligible Commonwealth countries; Bangladesh, Cameroon, Ghana, Guyana, India, Kenya, Kiribati, Lesotho, Malawi, Mozambique, Nigeria, Pakistan, Papua New Guinea, Rwanda, Samoa, Sierra Leone, Solomon Islands, Sri Lanka, Swaziland, Tanzania, Tuvalu, Uganda, Vanuata, Zambia

- the applicant is confirming they have not undertaken studies lasting 1 year or more in a developed country **or** that they or their family have sufficient money to pay for study in the United Kingdom without this scholarship.

FUNDING OFFER

- The successful applicant(s) will be sent a funding offer by the CSC.

- To accept the offer of funding the successful applicant must return all necessary documentation to the CSC Programme Officer as outlined in the notification of award letter from the CSC.

- The award recipient must complete the separate <u>UK bank account details</u> form and return this to the School as soon as possible (as instructed), and within 2 weeks of initial LSHTM registration at the latest.

- The award recipient agrees to not booking their own flight and to contacting the School once the necessary immigration visa has been obtained to organise booking a flight to the UK.

GENERAL
