# **Module Aim and Intended Learning Outcomes**

#### Overall aim of the module

The overall module aim is to:

• acquire knowledge and skills to implement and evaluate a district level eye care programme including the development and management of human, financial and technical resources, with emphasis on the student's work situation.

### **Module Intended Learning Outcomes**

Upon successful completion of the module a student will be able to:

- 1. Understand the concepts and strategies for district level eye health planning.
- 2. Understand the essentials of the planning process, including situational analysis, objectives setting, and developing an action plan that includes equity principles, stakeholder engagement, along with disability and patient-voice inclusion in that process.
- 3. Design an appropriate training course for health care workers.
- 4. Describe the principles of leadership and human resource management in health care.
- 5. Understand the principles of health promotion and its application in eye care and health care programmes.
- 6. Describe the principles of finance management and design appropriate budgets.
- 7. Know about appropriate technology and infrastructure with emphasis on eye care.
- 8. Describe how to monitor and evaluate a district level eye care programme.
- 9. Write a proposal plan for a district level eye care project.



# **Indicative Syllabus**

#### **Session Content**

The module is expected to cover the following topics:

- Planning for a district eye care service;
- Monitoring and evaluation eye care delivery;
- Need for human resources in eye care;
- Curriculum development for eye care workers;
- Leadership in eye care;
- Managing people in eye care;
- Health Promotion & Comm. Participation in eye care delivery;
- Technology for Eye Care;
- Using technology to deliver eye care;
- Managing Financial Resources.

Student contact time refers to the tutor-mediated time allocated to teaching, provision of guidance and feedback to students. This time includes activities that take place such as lectures, seminars, demonstrations, tutorials, practical classes, project supervision as well as where tutors are available for one-to-one discussions and interaction by email. Student contact time also includes tutor-mediated activities that take place in online environments, which may be synchronous (using real-time digital tools such as Zoom or Blackboard Collaborate Ultra) or asynchronous (using digital tools such as tutor-moderated discussion forums or blogs often delivered through the School's virtual learning environment, Moodle).

The division of notional learning hours listed above is indicative and is designed to inform students as to the relative split between interactive (online or on-campus) and self-directed study.



#### **Teaching and Learning Strategy**

The module provides guidance on how to plan a district level eye care programme. The module has lectures with discussion and integrated practical group work based on face-to-face teaching supported by a module manual together with access to PowerPoint presentations.

The assessment for this module has been designed to measure student learning against the module intended learning outcomes (ILOs) as listed above. Formative assessment methods may be used to measure students' progress. The grade for summative assessment(s) only will go towards the overall award GPA.

- A written proposal plan for an eye care initiative relevant to their work (60%).
