## **QUALITY & STANDARDS WORKPLAN**

The following workplan sets out a six-year schedule for review of different aspects of the School's quality assurance procedures.

- This is essentially a plan of 'thematic reviews', parallelling the periodic review process for courses. Staff or committees responsible for reviewing each topic are indicated.
- The aim is to ensure that all relevant areas of LSHTM policies and practice remain current, fit for purpose, and aligned with national best practices (particularly QAA's Quality Code).
- Reviews initiated under the workplan may be light-touch or more in-depth, as felt appropriate to the matter at hand when a review becomes due.
  The Dean and Associate Dean of Studies can advise on what level of consideration may be best in each case. The essential requirement is that existing School practice and documentation be reviewed, including against QAA's Quality Code, and any gaps or areas for improvement, enhancement or streamlining identified.
- In each case, any appropriate further actions should be put forward to relevant School committees for agreement, implementation and follow-up.

The workplan was first developed as a five-year plan agreed by QSC in July 2007; with a schedule for the following six years agreed by QSC in October 2011, as the initial five years drew to a close. Key items from the workplan addressed in each year have been reported to QSC at the end of each year – most recently, to QSC 04 July 2012 regarding the 2011-12 year – and the workplan kept updated accordingly.
